Employees pay increasing %s of premium, escalating over 4-7 years. Maximum premium share ranges from 16% for lowest paid to 30% for higher paid workers.

CWA Bargaining Proposal

Employees continue 1.5% of salary plus a premium share, increasing from 2% of premium to 5% of premium over 4 years. Total contribution is capped at 3% of salary or 25% of premium.
